2. Building stability and satisfactory electrical installation to be ascertained from concerned agency.

3. FCC shall stand null and void if there is any violation in existing firefighting arrangements.

4. FCC may not be treated in any case for regularization of unauthorized construction, if any or violation in building plan.

5. All fire safety arrangements provided therein shall be maintained in good working conditions at all time and all staff members shall be well acquainted to operate all fire safety equipments.

6. Any loss of life or property due to non-functional fire safety measures shall be at the responsibility of the management.

7. All staff should be trained in firefighting. Trained firefighting staff should be available round the clock.

8. Any deviation with regard to construction etc. shall be verified by the

concerned building sanctioning authority.

9. Means of escape shall be kept unobstructed/unlocked for unhindered evacuation in case of an emergency.

10. Occupant load in class room should be calculated at not less than 4 m2 floor area per students.

11. Occupant load of Auditorium at first floor of block-IV should be calculated at not less than 1.4 sqm floor area per student. The students from pre-primary to Class I should not be assembled in Auditorium.

12. Classes from pre-primary to 1st Standard should be at ground floor only.

14. The firefighting equipment register, mock drill register and staff training register should be updated regularly.
